The 2012 Ryder Cup® in Illinois promises to be one of the top sporting events of 2012, to follow up Europe's magnificent victory at Celtic Manor your USA team needs you there.

Medinah Country Club, the site of many of the most memorable moments spanning 60 years of major championship golf, will host the 39th Ryder Cup, Sept. 25-30, 2012, marking the Illinois debut of golf's most compelling event.



Located some 35 minutes from downtown Chicago, Medinah Country Club has hosted three U.S. Opens (1949, 1975 and 1990) and two PGA Championships (1999, 2006); while also the site of the 1988 U.S. Senior Open and three Western Opens [now BMW Championship] (1939, '62, '66). The PGA of America announced in October 1998 that Medinah would host the 2012 Ryder Cup®.

As part of its 2012 preparations, Medinah is nearing completion of a \$1.5 million greens renovation project on Course No. 3, led by renowned course architect Rees Jones. The project included a dramatic redesign of the 15th hole.

The 15th now offers players with a great risk-reward opportunity with a drive-able par-4 by reducing its length by 100 yards and adding a two-acre lake that borders the right side of the fairway and green. The new forward tee allows No. 15 to be set up as short at 280 yards. The original tee area of 392 yards from the championship tees will be preserved to provide the club with flexibility in course set-up.

This year, Medinah's famed No. 3 Course is ranked No. 20 by Golf Digest among "America's 100 Greatest Golf Courses." All three of Medinah's 18-hole courses were designed by Tom Bendelow in 1928 and completed two years apart.

Format Descriptions

Foursome Alternate Shot – Frequently referred to as Scotch Foursomes in the United States, this is alternate shot play. The first player on the two-man team hits from the tee, the second player on the team hits the next shot, the first player then hits the third shot and so on, until the ball is in the hole. The players on each team alternate drives, regardless of who sank the putt on the preceding green.

Fourball Better Ball – Commonly recognized in the United States as Better Ball. Fourball competition has one two-man team competing directly with a second two-man team. Each player plays his own ball and the better score of each pair decides the outcome of the hole.

Singles – This is the most basic format of the game of golf, one player against the other. Total strokes for the round are not considered; winning each hole is the goal.

NOT INCLUDED IN TOTAL PRICES: Laundry, telephone, items of a personal nature, meals not specified, and the Collision Waiver, Personal Assistance Accident Insurance, Gas, any item not listed in the program.

Deposit and Payment: (Ryder Cup® only) To ensure a reservation, a deposit of 50% of total price per person must be received by the operator within 14 days of confirmation. The balance of the total cost is required by April 1, 2012. Reservation & ticket prices cannot be guaranteed if all payments are not received by the operator by the due dates. Personal or company check or VISA, Mastercard or Discover/NOVUS are accepted. All reservations for which the deposit is not received within 14 days are automatically cancelled. Tickets: Upon completion of all payments, and approximately two weeks prior to departure each passenger will receive by mail all necessary tickets and certificates.

Cancellation Charges: If any trip is cancelled by SGH Golf (the Operator) all deposits and payments will be refunded in full.

Insurance: Travel insurance providing accident, baggage and cancellation protection is strongly recommended. Details and applications for low cost insurance will be provided to passengers with confirmation of reservations, or on request.
